Gowns must be paid in full and picked up by the set date on page one. gown must be paid in full despite any changes in wedding plans. Please notify universe bride of any date changes so that we can make the appropriate notations.

you, the customer, is responsible for choosing the size you want ordered. universe employees do not suggest or state a size that you need to order. we will show you the size chart specific to your gown and show you where your measurements fall. you and you alone decide your size! universe bride is in no way responsible for inaccurate sizes chosen. even though your gown is being ordered based on our measurements, it will need some degree of alteration work to achieve a perfect fit! If you do not understand this statement, please ask your consultant. No gown is ever a perfect fit. These gowns are not custom made.

Universe bride does not include alterations or pressing in the purchase price of your gown. Universe bride does not employ seamstresses. a referral list can be made available upon request.

ship dates from the manufacturers are **approximate** ship dates. Universe bride has absolutely no control over any ship date given. delays do occur and we will try to notify you of any issues. universe bride is not responsible for manufacturer delays.

If for any reason you decide to cancel your gown order, you will forfeit all monies paid on that gown. There are no refunds, credits, or exchanges permitted. If the gown is in layaway at universe bride, you will also forfeit the gown.

a minimum monthly payment is required on all wedding gowns. your payment must be received each month to keep your account active. if universe bride does not receive two consecutive payments, the gown and all monies paid will be forfeited and the gown will once again become property of universe bride. Universe bride will attempt to reach you by postcard or phone on delinquent accounts. a registered letter will be sent if we cannot reach you to notify you at that point.

gowns must be picked up from universe bride by the date set on page one. No exceptions! if a gown is left for more than two weeks after the scheduled pick up date, a \$50 storage fee will be assessed. If a gown is left longer than 30 days after the scheduled pick up date, it will once again become property of universe bride and you will have forfeited the gown and monies paid.

stock/floor gowns are sold as-is. you are responsible for any repairs. please inspect your gown carefully.

no layaways are permitted on "cash and carry" clearance gowns.
